**REQUIRED DOCUMENTS WITH EVERY APPLICATION:**

- PHOTO ID (valid driver license or state-issued id)
- VEHICLE ID (insurance car, registration or title) FOR EACH RESIDENT PERMIT REQUESTED
- HOME OR BUSINESS OCCUPANCY (utility bill, lease, closed sale contract or occupancy permit)
- PAYMENT BY CHECK, MONEY-ORDER OR DEBIT/CREDIT CARD\*. Resident permits are \$10 each through December. Residential permits issued January, February and March are \$6 each, or if issued April, May and June, \$5 each. Business permits (limit of 5 per business site) are \$15 each through December and \$10 each January through June.

*\*A \$1 processing fee per permit will be added for Card payments*

**\$20 FEE ON ALL RETURNED CHECKS (or permit[s] will be invalidated & the City will issue parking tickets).**

**IMPORTANT NOTICE: 17.104.050 Penalty for Violation (Ordinance 67530)**

- A. Any person, firm or corporation who shall park or cause to be parked any vehicle in violation of the provisions of this chapter shall upon the conviction thereof be fined twenty dollars (\$25.00) for each such offense.
- B. Any person, firm or corporation who shall distribute a resident or visitor parking permit to any person, firm or corporation not authorized to display such parking permit, his or her parking permit shall be suspended by the Traffic and Transportation Administrator for a period not to exceed one year.
